I. Impact of the Bangalore Metro Rail (Reach 6) on Vulnerable Communities

Bangalore Metro Rail Project or Namma Metro, was implemented in the year 2011 by Bengaluru Metro Rail Corporation Limited (BMRCL) to ease traffic pressure in the Silicon Valley. While BMRCL has conducted an Environmental Impact Assessment (EIA) and a Social Impact Assessment (SIA) for the Reach 6, and addressed some concerns emerging from the land acquisition and demolition of property, there is need for an assessment of the impact of this infrastructure facility to ensure a socially just approach to development.

Snehakuja intends to assess the social and environmental impact of the Reach 6 alignment. The critical gaps in the EIA and SIA process conducted by the BMRCL will be addressed by reviewing the applicable legislations, policies and regulations to ensure compliance. It will also identify the vulnerable groups, characterizing them by age, gender, economic backgrounds, and other related factors.

Snehakunja proposes to documenting the impact of the Metro Rail in terms of the types of losses, issues, both direct-indirect impacts and corroborating these impressions with people's perceptions, through public consultations and involvement in the study area, finally suggesting recommendations for building capacities of stakeholders i.e., Project Affected People to address the impacts.

As of 31st December 2020, the secondary data collection on the project, including the station-wise details has been completed. A review of BMRCL's EIA and SIA assessments has also been completed.

II. Project Title: SSRC - Ruptures and gendered adaptations of Social Economy of Small - Scale Fisheries of Indian Ocean Region Scoping study in Tamil Nadu and Karnataka

Small-scale fisheries are diverse and vitally important resource economies that underpin the livelihoods and nutrition security of millions of people across the Indian Ocean (IO) region. Yet, these economies and the communities they support are enmeshed in political ecologies of change that are heightening their vulnerability. Mounting, synergistic threats include climate change, pollution, overfishing, inter-sectoral competition, and changing institutional regimes of resource appropriation and control of space.

The objective of this proposed planning project is to convene an international, interdisciplinary group of scholars who conduct research on fisheries across four IO countries - India, Sri Lanka, Cambodia, and Tanzania. Our research question is to understand how different regional social economies of fisheries in the

IO shape possibilities for adaptation to rupture. This project attempts to capture the various spatial-temporal developments along the coastline and their effects in particular on the small-scale fishing communities. Several 'ruptures' have been identified along the Indian coastline which are affecting or continuing to affect the coastal ecosystem, livelihoods and food security of the local communities.

Coming to Karnataka coastline, we have shown how the 'blue economy' policies favoring large scale fishing activities, port infrastructure development and beach tourism, have resulted in squeezing the effective space of operation for the traditional small-scale fishing and its value chain. The setting up of Special Economic Zones and non-implementation of the Coastal Regulation Zone guidelines has added different dimensions to the developments. Further, the impetus on commercialization of the coast has exacerbated this process.

The project suggests that inclusive policies and practices and engagement with the communities in the decision-making process are necessary to balance the conflicts arising from competing resource use to ensure the blue economy benefits all instead of just a few powerful as is happening at present.

The Koragas are indigenous people who live in Dakshina Kannada (DK) and Udupi districts of Karnataka and Kasargod district of Kerala. Their distinct language and culture sets them miles apart from the dominant majoritarian culture. The community has been classified as a Particularly Vulnerable Tribal Group (PVTG), owing to its diminishing population (less than 24000 people in all) and shrinking cultural sphere. The Ajal practices, a set of inhuman and discriminatory practices dating back several centuries, which was prohibited through legislation in 2000 is still forced on Koragas in subtle forms. This practice along with others has been a reason for their historical subjugation in all ways possible.

The project aims at the capacity building of Koraga youth with a view to continue the work of the elder generation of the community who have dedicated their lives to pull the community out of this oppression. They worked hard to transform the social, educational and economic status of the community. Along with that, they have always emphasised on assertion of Koraga identity through their unique cultural expression forms through their collective 'Koral Kala Tanda' which was formed eleven years ago.

Collaborating with the Koraga Kala Tanda, the Koraga youth intends to keep the struggles of their ancestors alive, by passing on these stories of resistance, and by devising new ways to continue their movement towards the tribe's social, educational and economic progress.

As a first step, a training programme was conducted for the Koraga youth on the use of musical instruments such as 'Dolu, Chande, Chavala and Kolalu' in dessiminating the stories of their movements. This training programme was conducted in 4 phases between February and March 2021. The training ended with a public presentation by the trainees.

Accelerating incomes launched in July 2020, beginning with an assessment phase to understand the current state of FPOs in Andhra Pradesh and determine the potential for backyard poultry (BYP) as a profitable value chain.

The proposed project is undertaken with 3 Farmer Producer Organizations covering 2,800 small farmer households, spread across 39 villages in 21 Gram Panchayats in Rolla, Narpala and Tanakal mandals in Anantapur district in the drought prone Rayalaseema region of Andhra Pradesh, with the aim of improving their income and resilience through strengthening farmer collectives and collective backyard poultry value chain interventions. The overall project goal is to accelerate income growth for 3 FPOs, by strengthening their existing horticulture and input business lines and leveraging the potential of backyard poultry to improve the livelihoods of 2,800 smallholder farmers across the 3 FPOs in Anantapur, by 2022.

The objective of this study is to "map" the social economy of dried fish in Kerala State in comparison with Karnataka. Utilizing a feminist commodity chain approach, the project intends to conduct a historical spatial analysis of dried fish production (processing), trade, and consumption in order to understand the changing geography and social economy of dried fish, and how women's roles in the dried fish economy have changed as a result of broader economic, technological and geographic changes (e.g., introduction of trawling and its impacts on the geography of fish harvests, processing and trade locally and nationally). Importantly, the fous is on understanding how broad socio-economic and technological changes (e.g., mechanization, export markets, alternative proteins, fishmeal industry, migration) have impacted dried fish production/trade/consumption; and how consumption (changing consumer preferences) has impacted the structure and dynamics of dried fish value chains. The project will consist of two interrelated components. One will examine processing and trade; the other consumption.

Research objectives are to:

- Understand how fish flows across value chain nodes, i.e., from point of capture/harvest to processing, marketing, and finally consumption and how this has changed over time;
- Map the dried fish market system, identify key sites for fish procurement (landing /harvest sites), processing, and distribution and their relationships to one another;
- Assess if/how the geography of the dried fish market system has changed within the broader economic changes prompted by state-led fisheries development since circa 1959, noting when and key sites emerged or shifted and why.
- Analyze labor relations within and across value chain nodes, including divisions of labor (such as gender and communal divisions), the role of financial (credit) relations in structuring the market system, and the relationship between productive, reproductive and household labor in structuring the value chain and how these have changed over time;
- Understand how different groups of actors are connected to dried fish value chains and the power relations underlying the dried fish social economy, particularly focusing on processing and marketing;

Snehakunja Trust is a part of a trans-regional collaborative socioeconomic research project, with partner institutions from Canada, U.S., Kenya, Cambodia, and Sri Lanka. The objective of this proposed project is to investigate the impact of environmental and economic "ruptures" on small-scale fisheries (SSF) in the Indian Ocean region. Ruptures are acute shocks such as climate disasters, political crises, or economic crashes that destabilize the social, ecological, economic, and other arrangements that support small-scale fisheries.

We contend that across the region among the gravest of stresses to the social-economic fabric of SSF is the *shrinking space* for action. Literally, the physical space for SSF is increasingly restricted due to coastal appropriation and other long-term dispossession stresses. Our understanding of rupture and gendered adaptation is informed by three areas of literature appropriate to understanding processes of change that take place across geographic scale.
